**5. General Terms & Conditions of the Authorisation:**

- An application for the renewal of registration shall be made before 120 days of expiry of this EPR Registration Certificate

- That the applicant has to maintain all the technical documentation on RoHS as per EN50581 for verification by CPCB/SPCB officials whenever required;
- In case of any difference, between the details provided by producer and registered recycler the lower figure shall be considered towards fulfilment of extended producer responsibility obligation of the producer;
- In case of any violation of the above condition or violation of the rules provisions, your EPR Registration Certificate will be revoked/cancelled;
- Environmental compensation charges as deemed fit will shall be imposed for failing to meet recycling target or any other violation under the E-Waste Rules;
